

PRESIDENT'S MESSAGE 2013

As homeowners, belonging to a Homeowner's Association, at times we may question what impact this membership have on us, aside from the obvious primary one of maintaining and improving the common areas and parks. Examples include: Can I build a swimming pool in my backyard? How about a deck? Privacy fence? Henhouse?

The Association has a Building and Use Restrictions document (date 02/11/1970) which covers all lots in Carriage Hills. Most of the restrictions in this document pertain to the construction of homes, dealing with dwelling size, lot area and width, building location, easements and drains. The others are:

1. Fences: No fence or wall shall be erected, placed or altered on any lot nearer to any front street than the minimum building setback.

2. Temporary Structures: No structure of a temporary character, trailer, basement, tent, shack garage, barn or other outbuilding shall be used on any lot at any time as a residence either temporarily or permanently.

3. Signs: Only the following signs may be displayed to the public view on any lot in the subdivision: (a). One professional sign of not more than one square foot, (b). One sign of not more that five feet square advertising the property for sale or rent by an individual property owner desiring to sell or rent.

4. Livestock and Poultry: No animals, livestock, birds or poultry of any kind shall be raised, bred or kept on any lot, except that dogs, cats or other common household pets may be kept provided that they are not bred, kept or maintained for any commercial purposes.

5. Garbage and Refuse Disposal: No lot shall be used or maintained as a dumping ground for rubbish. Trash, garbage, or other waste shall not be kept except in closed sanitary containers. All incinerators or other equipment for the storage or disposal of such material shall be kept in a clean and sanitary condition.

That's it. My take on them is that there really aren't any restrictions for homeowners and what they do with their properties. The Township of Canton has other ideas, called ordinances. These can be found at <u>http://library.municode.com/index.aspx?clientId=13379</u>.

There is one Carriage Hills exception (unwritten) that will be enforced - dumping yard debris in the parks. This includes lawn clippings, branches, shrub trimmings, etc. It's so easy just to throw all this stuff over the back fence, because no one can see it or cares. NOT SO! You will be charged a \$100 cleanup fee, and may be in violation of Canton's anti-dumping ordinance (up to \$500). Please help us keep our parks looking like parks.
