#### CARRIAGE HILLS PARKS: UPCOMING CHANGES AND LOCATIONS

Carriage Hills has four parks that are maintained through your annual association fee. These parks belong to every resident in our subdivision and we want them to be enjoyable for everyone.

This summer we will be replacing the large play structure in Hanridge Park with equipment designed for the age range of 5-12 year olds, and the large play structure in Umberland Park with equipment designed for the age range of 2-5 year olds.

If you are visiting the parks or if someone you know is using the play equipment, we want your feedback if you find something that needs attention or repair. Some of the things we are most concerned about include broken equipment, fallen trees or limbs, trash, and vandalism. The board inspects the parks regularly, but we may not see issues right after they happen so please help to be our eyes and ears. Umberland Cir.; and **Paul Revere Park** between 6518 and 6506 Paul Revere Ln.
